I hereby authorize *Serenity Spirit Sea Burials* to make disposition of cremated remains of the deceased and to scatter the remains at sea in the Pacific Ocean, in accordance with State and Federal law.

“Scattering” consists of the scattering of cremated remains at sea by vessel. I understand that once the cremated remains of the deceased are scattered, they are unrecoverable. Once the scattering of the cremated remains has been performed, *Serenity Spirit Sea Burials* will dispose of the container which contained the cremated remains.

Once *Serenity Spirit Sea Burials* receives the cremated remains they will be scattered at a time of our discretion within approximately 15 to 45 days. The timing may be affected by local weather and sea conditions.

The obligation of *Serenity Spirit Sea Burials* shall be limited to the disposition of the cremated remains as directed herein. I agree to release and hold harmless *Serenity Spirit Sea Burials*, its affiliates, and their agents, employees, successors and assigns from any and all loss, damage, liability, or causes of action (including attorney's fees and expenses of litigation) in connection with the disposition of the cremated remains of the deceased as authorized herein or respect to the identification of said cremated remains as being those of the deceased.
